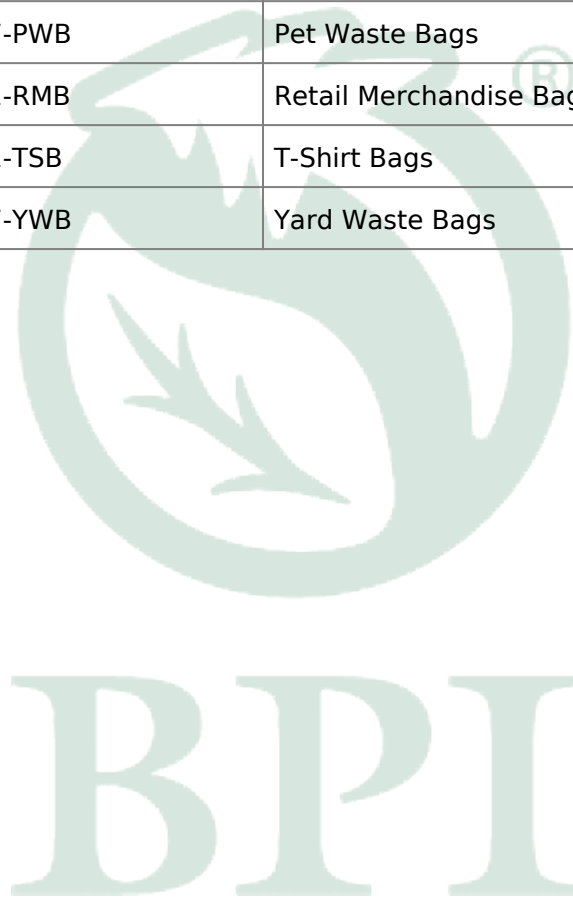



[Location and size]:

QINGDAO ZHOUSHI PLASTIC PACKAGING CO.,LTD (青岛周氏塑料包装有限公司) is Located at No. 212, Shuangyuan Road, Jihongtan Subdistrict, Chengyang District, Qingdao City, Shandong Province (山东省青岛市城阳区棘洪滩街道双元路212号). The Uniform Code of Social Credit is 91370214595291192R, valid from Jun 12, 2012 to long time.

[Structure of facility]:

The factory composed of one 2-storey building as office, 1F of one 2-storey building as production and warehouse, one flat building as dormitory with total about 9000 square meters.

Remark: 2F of the 2-storey production building was used by Qingdao Lianfa Wood Products Co., Ltd (access denied).

[Process of facility]:

The main business products were biodegradable products and plastic products. The main process included mixing, blowing film, printing, bag making, inspection and packing.

Main equipment and production line included: blowing film machines, printing machines, bag making machines etc.

All the processes were finished in the auditee, no subcontractors were used by the auditee, and nor homeworkers were used by the auditee.

[Employee analysis]:

A total of 48 employees including 35 male employees and 13 female employees were currently working in the auditee, there were 23 migrants from other provinces worked in the auditee.

No child labor and young workers worked in the auditee.

[Summary of working hours]:

Attendance records from Jul.1, 2021 to the audit day were reviewed in this audit.

All employees worked for 5 days a week from Monday to Friday in one shift.

Employees often overtime 1 hour at nights and sometimes overtime 9 hours on Saturdays.

Electric attendance machine was used for recording the working time and every employee should record attendances when they went in and out the facility.

As per management and workers interviews, the maximum overtime hour was 1 hour per day, 14 hours per week and 64 hours per month.

[Summary of compensation]:

Payroll records from Jul 2021 to Jun 2022 were reviewed during the audit.

All employees' wages were paid by hourly rate, and the lowest wage was RMB2300 per month which was higher than legal minimum wage RMB2100.

For overtime wages, 150% and 200% of regular wages were paid to employees for their overtime hours on workdays and rest days respectively, no overtime was arranged on statutory holidays.

The wages were paid in cash by 28th of the following month.

The auditee provided retirement, unemployment, work-related injury, medical and maternity insurances to all the employees.

[Summary of Interview]:

Worker interview were conducted individually and in group.

Randomly selected 8 employees, no complaints were raised.

[Special scene during on site observed]:

1. There was no contractor and agency used by the auditee, so the agency labour contract or contractor license/permit not applicable for the auditee.

2. The auditee did not obtain any government waivers.

3. There was no contractor license and collective bargaining agreement in the auditee.

4. The auditee didn't provide the building acceptance certificate for all the buildings during the audit.

Findings

PA1: Social Management System

Follow up Audit (Aug 3, 2022): Corrective action not taken: The auditee established management system; however it was not effective for some performance areas, such as Occupational Health and Safety and working hour etc.

跟进审核（2022年8月3日）：纠正措施未执行：被审核方已建立社会责任管理体系，但是并未有效执行 如职业健康和安全、工作时间等。

Follow up Audit (Aug 3, 2022): Corrective action not taken: The auditee did not effectively evaluate the production capacity, human resource and equipment status against the delivery requirement to avoid the excessive overtime work. The auditee did not establish a contingency plan for abrupt shutdown or stoppage in the workflow.

跟进审核（2022年8月3日）：纠正措施未执行：被审核方没有有效评估生产能力人力资源和设备状况以避免过量加班。被审核方没有建立应急停产程序。

PA 2: Workers Involvement and Protection

Follow up Audit (Aug 3, 2022): Corrective action not taken: The auditee had defined long term goals to protect its employees, but did not specify clearly how to achieve those goals step by step.

跟进审核（2022年8月3日）：纠正措施未执行：被审核方制定了保护工人的长期目标，但未显示如何循序渐进达成那些目标的过程。

Follow up Audit (Aug 3, 2022): Corrective action not taken: The auditee did not provide training about BSCI code to newcomers.

跟进审核（2022年8月3日）：纠正措施未执行：被审核方未给新入职工人提供关于BSCI行为守则的培训。

PA 6: Decent Working Hours

Follow up Audit (Aug 3, 2022): Corrective action not taken: Based on the working hour records provided by the factory, it was identified that all the workers had overtime worked exceed 36 hours in parts of the month, such as workers overtime 54 hours in Oct 2021, overtime 41 hours in Dec 2021 and overtime 64 hours in Jun 2022. The factory should make sure the monthly overtime didn't exceed 36 hours. Reference law/regulation: Article 41 of the PRC Labor Law.

跟进审核（2022年8月3日）：纠正措施未执行：基于工厂提供的工作时间记录，所有的员工在部分月份加班超过36小时，例如工人在2021年10月加班54小时，在2021年12月加班41小时，在2022年4月加班64小时，工厂应确保每月加班不得超过三十六小时。参照法规：《中华人民共和国劳动法》第41条的规定。

PA 7: Occupational Health and Safety

Follow up Audit (Aug 3, 2022): Corrective action not taken: The auditee was not yet to identify the regulations on occupational health and safety relevant for its operations and communicate the same to its workforce.

Follow up Audit (Aug 3, 2022): Corrective action not taken: The risk assessment of transmittable diseases did not cover the virus COVID-19.

跟进审核（2022年8月3日）：纠正措施未执行：被审核方的传染病风险评估没有包含2019冠状病毒病。

Follow up Audit (Aug 3, 2022): Corrective action not taken: During risk assessment, EHS management system developing and implementation, no worker representative was involved.

跟进审核（2022年8月3日）：纠正措施未执行：在风险评估过程，健康安全管理系统开发和执行过程中，无员工代表的参与。

Follow up Audit (Aug 3, 2022): Corrective action not taken: The auditee did not provide MSDS or secondary container for its chemical material such as printing ink stored in workshop. Reference law/regulation: Regulation For Chemical Usage Safety in Workplace, article 12
